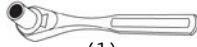

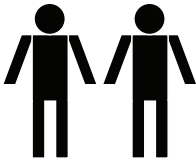

INSTALLATION & GROUND PREPARATION INSTRUCTIONS

- Place the equipment on a level, well-drained ground, not less than 6 ft (1.8 m) from any structure or obstruction such as a fence, garage, or house.
- Provide enough room so that children can use the equipment safely. For example, for structures with multiple play activities, a slide should not exit in front of a swing.
- Separate active and quiet activities from each other. For example, locate sandboxes away from swings or use a guardrail or barrier to separate the sandbox from the movement of the swings.
- Do not install home playground equipment over concrete, asphalt, packed earth, grass, carpet, or any other hard surface. A fall onto a hard surface can result in serious injury to the equipment user (see page 8).
- To prevent serious injury, warn children that they must not use the equipment until properly installed.
- Create a site free of obstacles that could cause injuries – such as low overhanging tree branches, overhead wires, tree stumps and/or roots, large rocks, bricks, and concrete.
- Choose a level location for the equipment. This can reduce the likelihood of the play set tipping over and loose-fill surfacing materials washing away during heavy rains

PLAYGROUND AND SURFACE MATERIALS INSTRUCTIONS

- Use containment, such as digging out around the perimeter and/or lining the perimeter with landscape edging.
- Do not install loose fill surfacing over hard surfaces such as concrete or asphalt.
- Installations of rubber tiles or poured-in-place surfaces (other than loose-fill materials) generally require a professional and are not “do-it yourself” projects.
- Use Playground Surfacing Materials (other than loose-fill material) which comply to the safety standard ASTM F1292 Standard Specification for Impact Attenuation of Surfacing Materials within the Use Zone of Playground Equipment.

OPERATING INSTRUCTIONS

Observing the following instructions and warnings reduces the likelihood of serious or fatal injury:

- The maximum number of occupants that may safely use the entire playset is four with a maximum weight of 400 pounds (181 kg).
- On-site adult supervision should be provided for children of all ages.
- Instruct children not to use the equipment in a manner other than intended.
- To prevent entanglement and strangulation, dress children appropriately using well-fitting shoes and avoiding ponchos, scarves, jackets with neck drawstrings, helmets with straps, and other loose-fitting clothing that is potentially hazardous while using equipment.
- Instruct children not to play when the equipment is wet.
- Instruct children not to attach items to the playground equipment that are not specifically designed for use with the equipment, such as, but not limited to, jump ropes, clothesline, pet leashes, cables and chain as they may cause a strangulation hazard.
- Do not move the equipment while it is in use.

MAINTENANCE INSTRUCTIONS

- If routine checks and maintenance procedures are not done, the equipment could overturn and/or become a hazard.
- Check surfacing material and replenish as necessary to maintain proper depth (see page 8).
- Rake surfacing periodically to prevent compaction and maintain appropriate depths.
- Remove any tripping hazards, such as exposed concrete footings, tree stumps, or rocks.
- Check all nuts and bolts twice monthly during the usage season for tightness and tighten as required. It is particularly important that this procedure be followed at the beginning of each season.
- Check all coverings for bolts and sharp edges twice monthly during usage season to be certain they are in place. Replace when necessary. It is especially important to do this at the beginning of each new season.
- Do not use the equipment when the temperature drops below 32°F (0°C).
- Sand rusted areas on tubular members and repaint using a nonlead-based paint meeting the requirements of Title 16 CFR Part 1303.

CONSUMER INFORMATION SHEET FOR PLAYGROUND SURFACING MATERIALS*

The U.S. Consumer Product Safety Commission (CPSC) estimates that about 100,000 playground equipment related injuries resulting from falls to the ground surface are treated annually in U.S. hospital emergency rooms. Injuries involving this hazard pattern tend to be among the most serious of all playground injuries, and have the potential to be fatal, particularly when the injury is to the head. The surface under and around playground equipment can be a major factor in determining the injury causing potential of a fall. It is self evident that a fall onto a shock-absorbing surface is less likely to cause a serious injury than a fall onto a hard surface. Playground equipment should never be placed on hard surfaces such as concrete or asphalt and while grass may appear to be acceptable, it may quickly turn to hard packed earth in areas of high traffic. Shredded bark mulch, wood chips, fine sand or fine gravel are considered to be acceptable shock-absorbing surfaces when installed and maintained at a sufficient depth under and around playground equipment.

Table 1 lists the maximum height from which a child would not be expected to sustain a life-threatening head injury in a fall onto different loose-fill surfacing

materials if they are installed and maintained at depths of 6, 9, and 12 inches. However, it should be recognized that all injuries due to falls cannot be prevented no matter what surfacing material is used.

It is recommended that a shock-absorbing material should extend a minimum of 6 ft. in all directions from the perimeter of stationary equipment such as climbers and slides. However, because children may deliberately jump from a moving swing, the shock absorbing material should extend in the front and rear of a swing a minimum distance of 2 times the height of the pivot point measured from a point directly beneath the pivot on the supporting structure.

This information is intended to assist in comparing the relative shock-absorbing properties of various materials. No particular material is recommended over another. However, each material is only effective when properly maintained. Materials should be checked periodically and replenished to maintain correct depth as determined necessary for your equipment. The choice of a material depends on the type and height of the playground equipment, the availability of the material in your area, and its cost.

****The maximum fall height for this product is 60 in (152 cm).**

We recommend using 6 in (15 cm) of Double Shredded Bark Mulch. **

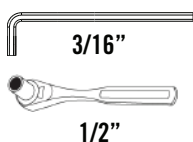
Slide a **Washer (ARL)** over a **5/16" x 1 3/4" Bolt (ASI)**, then slide the Bolt through the two **Green Tubes with Sticker (CPF)** and four **Light Brown Tubes (CPD)** in the order indicated by the numbers. Slide another Washer over the Bolt and secure with a **5/16" Standard Nut (ATL)**. Hold the Nut with a wrench while tightening the Bolt. Tighten completely to prevent movement.



Note: Repeat this step five times, making five joints.

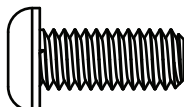

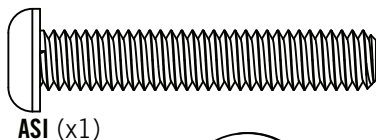
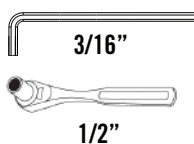
Attach a **Light Brown Tube (CPD)** to the bottom of the assembly completed in the previous step (Joint A). Slide a **5/16" x 3/4" Bolt (ARN)** through a **Washer (ARL)** and the two Light Brown Tubes. Place a Washer over the Bolt and finger tighten a **Nylock Nut (ASE)** for removal later. Follow the same assembly for Joint B.



Note: Repeat this step on all five assemblies.



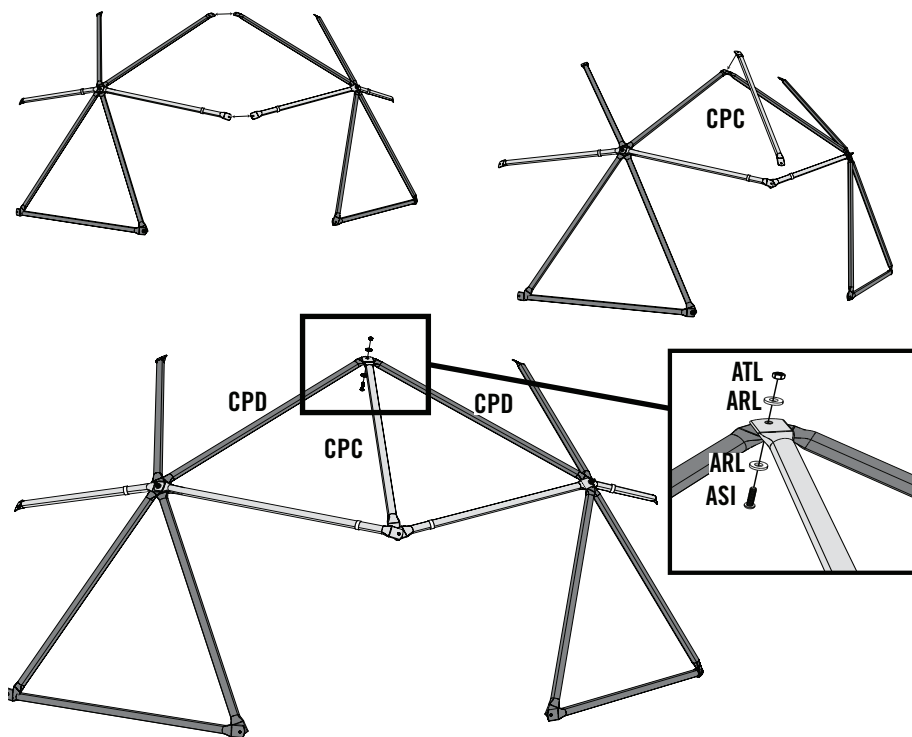

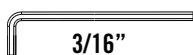
Bring the assemblies completed in steps 1.1 and 1.2 together as shown. Place a **Green Tube (CPC)** over the **Light Brown Tubes (CPD)** and secure the Green and Light Brown Tubes together at the top joint as shown below by placing a **5/16" x 1 3/4" Bolt (ASI)** through **Washer (ARL)** then through the Brown Tubes and Green Tube. Place a Washer over the Bolt and finger tighten the **5/16" Standard Nut (ATL)** for removal later.



Note: The Geo-Dome should be stood upright to complete this step and the rest of the assembly.

Secure the **Light Brown Tube** and **Green Tubes (CPC)** to the existing joint by replacing the **Washer (ARL)** and the **Nylock Nut**. Tighten completely.



Note: Make sure all Bolts on the bottom go in the direction shown, with the head of the Bolt on the outside, to prevent injury.



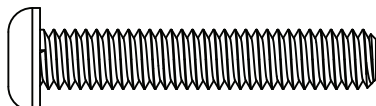

Remove the hardware at Joint E. Place the removed Bolt and Washer through the added Light Brown Tubes with Stickers (CPE), and **Green Tube with Sticker (CPF)** in the order indicated. Replace the hardware and tighten joint completely. Complete around the circle.



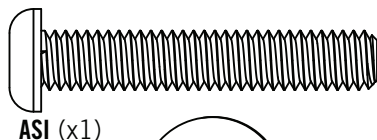

Attach **Handholds (CPB)** to each of the joints not touching the ground. Attach the handholds by sliding a **Washer (ARL)** over the **1 3/4" Bolt (ASI)** and placing the Handhold over the Bolt. ***It is critical that the Washer is added.*** Line up the notch on the bottom of the Handhold with the tube on the top of the joint. Secure each Handhold with a Washer and **5/16" Nylock Nut (ASE)**. Tighten completely.

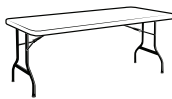
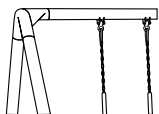
